



## Consignment Agreement

**All items must be clean, rust free and in good working order.** Tool Belt Consignments, LLC reserves the right to reject any item. We do not accept clothing, furniture, jewelry, housewares, guns, or children's items for consignment. Our goal is to provide the finest items for our customers. We will only accept items that we believe will sell quickly.

1. Tool Belt Consignments, LLC assumes no responsibility for the loss of, damage to, or destruction of any article left on consignment.
2. The Consignor represents and warrants to Tool Belt Consignments, LLC that he/she is the owner of the items consigned to Tool Belt Consignments, LLC under this contract OR that the Consignor has full legal authority to consign items.
3. Unless previous arrangements have been made, the Consignor is solely responsible for the delivery and pick up of all items including loading and unloading at Tool Belt Consignments, LLC.
4. Tool Belt Consignments, LLC welcomes suggestions for pricing items consigned, however, Tool Belt Consignments, LLC retains the right to determine the pricing for items and the Consignor agrees to the prices arrived at by Tool Belt Consignments, LLC.
5. Items are accepted on a 90-day consignment period. Items will be marked down 10% from the original price after 30 days and 20% of original price after 60 days. At the end of the 90-day consignment period the Consignor is given 30 days to pick up unsold items. At the end of 30 business days we are no longer responsible for storing your items, the commission split ends and items are non-retrievable. Un-sold items left for 30 days past the end of the consignment period are abandoned by consignor and become property of Tool Belt Consignments LLC to recycle, sell or otherwise remove for disposal.
6. Items can be re-claimed prior to end of the consignment period by paying a consignment fee of 10% of the selling price.
7. Our inventory will be listed online as well. If an item is sold on eBay, the eBay fees will be subtracted from the sale price prior to calculating the consignment split.

8. Tool Belt Consignments, LLC will pay the consignor 50% of the sale price on items that sold during the month. Checks to the Consignor for items sold will be ready for pick up after the 10th of each month for the Consignor's items that sold during the previous month (ex. if your item sold in September, your check will be ready for pickup on October 10<sup>th</sup>). At his or her request, the Consignor may also opt to receive payment via PayPal, or choose to use their balance as store credit towards the purchase of an item.
